## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Abergwyngregyn Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

#### Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

#### Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

#### Treatment of unpresented cheques

The Council appears to have incorrectly treated unpresented cheques and has reported the closing balance based on the balance held at the bank rather than the balance recorded in the Council's cashbook. There is an unpresented cheque of £103.

We recommend that the Council refers to the Practitioners' Guide for guidance on treatment of unpresented cheques.

#### Action taken in response to internal and external audit reports

The Council has stated in the Annual Governance Statement that it has not taken appropriate action in response to internal and external audit reports.

We recommend that when the Council receives audit reports it discusses the findings and takes appropriate steps to address any weaknesses identified.

#### Publication of information on the Council's website

The Council is required to publish certain information on its website by the Local Government (Democracy) Wales) Act 2013. One of the items to be published is the Auditor General's report and opinion. However, the Council has not published the opinions alongside the annual returns.

We recommend that once it receives the audited annual return, the Council replaces the unaudited version with the audited return that has the audit opinion and report attached.

#### Fixed assets

In the Accounting Statement, the Council discloses it holds no fixed assets. However, the Council does insure a series of assets including (amongst other items) playground equipment war memorials, mowers and machinery and sports equipment. The value declared for insurance purposes totals £100,331.

We recommend the Council reviews its valuation of assets reported in the accounts.

There are no further matters I wish to draw to the Council's attention.
