

# Cyngor Cymuned Abergwyngregyn

**Extra council meeting on 20 July 2022 at 7:30 p.m at Yr Hen Felin.**

1. Clerk welcomed everybody and explained that a short meeting was held on June 20th to co-opt 2 new Councillors, Jenny Alty and Helen Flook. Clerk explained that Dewi Roberts (Chair), Liz McSweeney (Vice Chair), Gwerfyl Morriss and Carwyn Jones had not stood for reelection.

2. Elect new chair.
